Resumo: este ensaio avalia criticamente os paradigmas da teoria econômica neoclássica a partir da crise mundial de 2007-2008, assim como a trajetória das economias latino-americanas após a crise. A crise reforçou a desigualdade nas décadas de 1970 e que provavelmente um aumento acentuado da desigualdade em praticamente todos os países. A redução da desigualdade que ocorreu na década de 2000 é atribuída, sobretudo, à ascensão de governos de centro e centro-esquerda no subcontinente. Num perspectiva de longo prazo, evidencia-se que os indicadores Gini de desigualdade, em 2010, apenas retornaram aos valores de 1960.

A NEVER ENDING RECESSION? THE VICISITUDES OF ECONOMICS AND ECONOMIC POLICIES FROM A LATIN AMERICAN PERSPECTIVE

Abstract: this essay discusses the paradigms of neoclassical economic theory, from a latin American perspective. In the first section, recent changes in economic theory and the paradigms that were the basis for economic development are discussed. The economic crisis, past and present, destroyed economic theory paradigms. In the second section observations are presented, regarding the trajectory followed by Latin American economies after the crisis, and the introduction of structural and liberalization reforms, closely related to the neoliberal paradigms installed as dominant ideas. In a long term perspective it is possible to identify that Radical Left and Social Democrat Left governments did manage to reduce inequality between 2000 and 2010 quite substantially, but that in several countries inequality was more intensive in 2010 than in 1960 or in 1980, and where reduction occurred, it was minimal.
