INTRODUCTION

Whilst research into restorative justice and its cost effectiveness can be important in achieving goals such as reducing crime rates, an important question is whether the evaluation of restorative justice and its implementation should be undertaken from the perspective of the state - whose multiple aims are reducing recidivism, crime reduction and delivering justice fairly and efficiently, or the individual - where minimum standards in processes and outcomes are deemed important, or lay participants (defendants, victims, witnesses and local communities) whose main concerns are forward looking problem solving and crime prevention aims? Evaluations have generally focused on victim-offender mediation and family group conferencing (Kunk, 2003), addressing issues such as participant satisfaction, procedural justice, 'restorativeness' (restorative quality) and outcomes.

In the evolution of restorative justice, practice has preceded theory. It is therefore significant 'aspects of practice' to be considered which may or may not be responsible for the positive outcomes observed in research. Over the last decade or so, studies worldwide have attempted to assess the impact of restorative practices at multiple levels with case types ranging from first time offenders and misdemeanors to more serious, chronic and/or violent offenders. While on the one hand, researchers might theorise on success in restorative encounters, and on the other, evaluative studies should not be confined to the realm of academic debate alone.
